

On Monday, October 3, 2022, at 5:00pm, the Town Council held a Council Workshop at the Town Hall located at 121 North Gate Road, Myrtle Beach, South Carolina 29572.

The media and public were duly notified of the date, time, and place of the Workshop. At 5:00pm, with a quorum present, Mayor Buonviri called the Workshop to order.

Mayor Buonviri began the Workshop with a quick overview and purpose of the Agenda.

Discussions followed, beginning with Mayor Buonviri:

**Road Resurfacing Bid Package #2022.03** – The Clerk received four bids for the project; Council reviewed the bids. The bids will be vetted, and the lowest, qualified bidder will be awarded at the Town Meeting. The Clerk will post the bid tabulation on the Town website:

**Hurricane Ian update** – The Town declared a **State of Emergency** on Friday, September 30, 2022, in preparation for the storm. The State Emergency Management Division (EMD) has yet to make a declaration of the event. Parkman Tree Service cleared the roads immediately as the preposition agreement was invoked. Concerns about construction debris in North Lake were discussed.

**Landscape Maintenance Contract** – The Mayor will discuss areas of need with Vereen in reference to clean-up from the storm.

**Mayor Tempore Bell:** - **Beautification** – Bell received a price for the kiosk at Center Drive and Middle Gate and is waiting for a paver price.

**Public Tree Ordinance** – Some minor elements will be removed; second reading will take place at the Town Meeting.

**Councilman Palliser**: Lakes – The Councilman will request extra testing for the Lakes due to the construction debris.

**Councilwoman Pendley: Communication** - In her absence, Mayor Buonviri provided a report stating that she will update Council on the emergency texting, Facebook, and email for the storm at the Town Meeting.

**Councilman Wylie: Trees** - Wylie noted that many of the downed Oaks are hollow from ant infestation. He requested a second notice be sent to residents with the debris stipulations.

**Chief Lamparter: Public Safety** – The Chief will be attending a class, Crime Prevention through Environmental Design, and invited members of Council and staff to attend. He will provide a report at the Town Meeting.

**Clerk: Reporting** was completed earlier. She will keep Council advised of her upcoming absence.

The Clerk added **Items** to the Town Meeting Agenda.

No further matters requiring attention were discussed.

No Public Input was shared during the session.

The date and time of the upcoming **Meeting**(*s*) was announced, and with no further business to discuss, at 5:51pm, the Council Workshop adjourned.
